

# AS America, Inc. (“American Standard”) Limited Warranty – Bathing

## **General Terms and Requirements**

American Standard warrants each Product to be free of defects in material and workmanship during normal residential or commercial use for the relevant time periods identified [here](#), measured from the initial date of purchase.

This warranty extends only to the **original purchaser** and is non-transferable unless purchased by a plumber, contractor or other service provider, in which case this warranty extends to the first property owner on whose behalf the product was purchased for installation.

This warranty gives you specific legal rights, and you may also have other rights which vary from state to state or province to province.

## **Exclusions and Limitations**

American Standard’s obligations under this warranty are limited to the repair or replacement of the Product or any part, or exchange of the Product for the same or a similar model, in its sole discretion. American Standard reserves the right to make inspections it deems necessary.

### **WARNING:** This warranty **DOES NOT COVER:**

- (I) Any damages caused by lack of proper maintenance or cleaning as directed in the owner’s manual.
- (II) Any damages that occur during shipment.
- (III) Any damages to personal or real property from use of the Product.
- (IV) Any damages from negligent or improper installation or use of non-genuine American Standard Parts.
- (V) Any damages caused by factors beyond the control of American Standard, such as installation, maintenance and normal wear and tear.
- (VI) Failure of the Product or parts thereof from external forces such as, but not limited to, vandalism, vehicular or other impact.
- (VII) Local building code compliance. Purchasers should check with a local building or plumbing contractor to ensure local code compliance before installation.
- (VIII) Labor or other costs of removal or installation, including any costs of any surrounding material (such as tile or marble).
- (IX) Any damages caused by an Act of God or natural disaster (such as earthquake, storm, hurricane, lightning strike, tornado, hail, cyclone, typhoon, blizzard, volcanic activity, landslide, tidal wave, tsunami, flood, drought); outbreaks of infectious disease or any other public health crisis; explosion, fire, prolonged break-down of transport; shortage or inability to obtain critical material or supplies to the extent not subject to the reasonable control of American Standard; or any other event or condition beyond its reasonable control.

- (III) Was not installed in accordance with instructions. If the access panel is covered in any manner contrary to the installation instructions.
- (IV) Has been modified or altered in a manner inconsistent with the Product as shipped by American Standard.
- (V) Was purchased from an unauthorized seller.
- (VI) Was accidentally or intentionally damaged.
- (VII) Was used in a manner for which it was not designed.
- (VIII) Was improperly shipped, stored or handled.
